- Received Joe Mahood's sponsorship of 250.00 from Hilltop Engine Co. No 1

A motion to accept all reports as given was seconded and approved.

Old Business

- Excused absences- Tolland County-excused CT Valley Bassmasters & CT Bassmen did not ask for an excuse. I asked them and they said they did not want it.
- Vote on 2016 & Beyond Proposal was passed out and each club voted and passed them to Vinny. Vinny counted and the vote was unanimous to accept the new tournament trail format as follow;

New Trail Format for 2016

<u>CBN Tournament Trail</u> – Will consist of three events with the entry fees for each being \$75 for a boater and \$35 for a non-boater. These three events will run as they have in the past where some boaters may not be paired with a non-boater. These are Pro/Am style events. The boater has control of the boat at all times. The CBN trail will utilize the same payout criteria as in past years. The 20% of entry fees that were previously retained to fund the Classic payout will now fund the State Team.

<u>CBN Classic</u> – The top 25 boaters and the top 25 non-boaters in the Angler of the Year standings from the three previous CBN Tournament Trail events will qualify for this event. All participants must be paired. The entry fee will be \$100 for a boater and \$50 for a non-boater. The point standings from the previous three tournament trail events will be reset to zero. The top three finishers in each division will qualify for the State Team. This is a Pro/Am style event. The boater has control of the boat at all times. There will be no cash payout. 100% of entry fees will be retained and utilized to fund the State Team

<u>Bryan V. Kerchal Tournament of Club Champions (Mr. Bass)</u> – Each club must provide a boater and a non-boater for this event. The entry fee will be \$100 for the boater and \$50 for the nonboater. The first place finisher in each division will qualify for the State Team. This is a Pro/Am style event. The boater has control of the boat at all times. There will be no cash payout. 100% of entry fees will be retained and utilized to fund the State Team

<u>Two Day State Championship</u> – This tournament will be open to all CBN members. Each boater must have a linked non-boater listed on their application to ensure all participants are paired. The entry fee for this event will be \$150 for a boater and \$100 for a non-boater. The top seven finishers in each division will qualify for the State Team. The seventh place finisher from each division will hold the position of team alternate. This is a Pro/Am style event. The boater has control of the boat at all times. 100% of entry fees will be retained and utilized to fund the State Team.

- CBN/NEBA TCT held T #3 on Lake Champlain all 22 Teams attended. So far Reed Johnson & Justin Mesick are leading the CBN/NEBA TCT.
 - The NRD Grant: Dean has redone the Scope of Work and sent it to Andrew to be submitted. Cross your Fingers, this could be it!!!
- Folds of Honor Tournament was held and we had 13 Teams and raised 780.00 for Folds of Honor. Karl Sundquist won Lunker, 130.00 and gave it to Folds of Honor!!! Thank you Karl!!! So a total of 910.00 was sent to Folds of Honor!!! Hopefully will do better next year!!!

Executive Board Meeting report from May

- Called to order at 5:45
- Treasurer report was given.
- Discussed Tournament Trail and what is needed for 2016.
- We will be purchasing a New Computer and a new Scale, using the old one as a backup. Ron will search for us. If anyone knows of a possible sponsor that will buy these items for us, that would be great!!!
- Discussed the proposed Trail and all the changes coming in 2016.
- CBN/NEBA Trail has lost some Teams. Will continue to do it as long as we have 20 Teams. This year we have 22.
- Discussed the Trailer Wrap. As you have seen it is beautiful!
- We do have room for more Sponsors, let us know if you know of anyone.
- We are working on adjusting the Sponsorship letters now.
- Scholarship Issues were discussed, Tournament is not bringing in what is needed to cover the \$4000.00 given out each year between the two Scholarships. We decided to cut down the AMOUNT OF Scholarships given for next year. We only have 7 apps this year!!! We will do the CBN Scholarships as 1st & 2nd only. No 3rd place anymore. 1st will be 1000.00 and 2nd will be 500.00. We will continue the RMS at \$1000.00. Saving 1500.00. We will now be giving out \$2500.00. We need to build the Scholarship Tournament. We took in 1920.00 this year. We need to bring in 2500.00 next year.
- We addressed the High School/ Junior Trail and realized we are growing in High Schools b but not in Boat Captains. We decided to cap the program at 15 Boats. Right now we have the High School Teams and Juniors to fill the 15. So if any schools want to come in they can if they can supply a Boat Captain, if not they go on a waiting list for now unless we can come up with more Boat Captains! We will revisit this prior to the start of next year and see where we are at with Boat Captains; hopefully we will have more lined up and can then take new schools!!! We will not be looking for New Juniors for now either. Same applies to them, if they can get a Boat Captain they can come in.
- We have appointed Ron Frisk High School/Youth Director going forward in 2016. We have also appointed John Piscioniere his assistant; he has already been helping out this year.

Terry Baksay has given us a lot of years as Youth Director and we would ;like to say Thank you!!!, However he is very busy and has not attended a meeting in 15 months so Ron has been doing all the work and is interested in being High School/ Youth Director.

Ron cannot attend the Nationals in November so Vinny or Al will be attending in his place along with Sylvia.

- We talked about the State Team and the upcoming cost increase!! We will be trimming the fat, no oil or license reimbursement, starting this year. Going forward for 2016 all members will have to bring in a monetary Sponsorship only no merchandise or discounts, cash only. The amount will be set when we have a better handle of where we are going for the Divisional and how much the 2016 Trail brings in.
