COMMITTEE & INITIATIVES REPORTS Budget and Legislative Report – Rick Jacobson & Tony Petrillo Policy The Fisheries Division submitted a number of recommendations for bills.

The regulations for dual landings will go to the regulations review committee next week.

**Budget** 

Sport Fish Restoration account funding has increased and Wildlife Restoration funds have decreased No change in the state budget at this time. Cap in the number of positions that can be filled but DEEP continues to have authorization to fill vacant positions.

Last week the house Natural Resources Committee passed the Recovering America's Wildlife Act. It now goes to the House of Representatives. Potential for \$1.3 billion dollars annually. Potential for \$12 MM annually for Connecticut that will go into a special fund and restrictions on what the funds can be used for. These funds require matching funds.

Fisheries is receiving \$556K from the Passports to Parks.

**Regulations Package** 

**Statewide Carp regulations** 

There is now a creel limit of 5 common carp per day, with no more than 1 fish greater than 30 inches in length except in trophy carp waters. Unanticipated opposition prompted legislative action requiring DEEP to develop regulations concerning bow and arrow fishing for carp in selected areas.

Establishing alternative regulations (twelve fish per day creel limit, of which not more than three may exceed thirty inches in length) specific to bow fishing in selected areas described in statute. The proposal now includes West Thomson Lake.

There will be an update to the bowfishing definition that was very out of date.

Tiger Muskie

**Requested by Lake Lillinonah Authority** 

This proposal includes Tiger Muskie in the definition of Northern Pike and applies the legal methods of take, creel limits.

Add a closed season to Black Rock State Park

Black Pond and Mohawk Pond are added to the list of Trout Management Lakes and are managed for Brook Trout. Proposal would establish length and creel limits for Brook Trout (5 trout per day creel limit but only one Brook Trout over 14 inches in length during the regular trout season, and a one fish per day creel limit and 14-inch minimum length for Brook Trout during the extended March season.

Stocked Catfish waters – Add colony Pond, Crescent Lake, and Rogers Park pond

Atlantic Salmon Broodstock Areas. Changes designation to "Atlantic Salmon Management Areas to better reflect current management goals.

Bridle shiner - Remove Bridle Shiner from the list of inland commercial species.

Eliminate outdated provisions concerning the now defunct Quinebaug Valley Trout Hatchery Public Fishing Ponds. Eliminate outdated provisions concerning a statewide closed

Colebrook Reservoir Drawdown

Work on first conduit is complete, the second conduit is being reassembled, and then work will start on third and land conduit. According to ACOE, work will be complete on January 15. Fall Atlantic Salmon Fishery - Will stock 1,020 salmon this fall PFAS Advisory will remain in place while officials evaluate the potential impacts to the watershed.

CT Carp Open 2019 report

The Sea-run Brown trout program has been indefinitely due to poor results. There has been no evidence of any fish surviving in estuarine/marine waters and then returning to their stream of origin. National Fish Habitat Conservation Through Partnerships Act legislation was approved by the house which has now been moved to the Senate for consideration.

**Marine Fisheries Report – Justin Davis** 

**Black Seabass and Scup** 

Black Seabass is at 240% of target biomass. However, there may be a 60% reduction in harvest next year due to the MRIP re-estimation. Striped Bass

Coast-wide 28-35" slot limit

All states will be required to adopt regulations mandating the use of circle hooks

States have the option of submitting a "conservation equivalency" proposal to adopt alternate recreational regulations, provided those proposed regulation are projected to achieve an 18% reduction in that state's removal.

Bluefish

Stock is overfished. There will be a 30% reduction next year. Conservation equivalency is also an option for Bluefish. CT may submit a CE for shore anglers.

Menhaden

Restrictive cap in Chesapeake Bay in 2017. Virginia has failed to pass legislation to implement this cap. Omega Protein notified ASMFC that they intend to exceed the cap and adhere to a self-imposed cap that far exceeds the ASMFC cap.

Eric asked if there were comments on the Trout and Salmon Stamp. Mike said that people now seem to realize that they money is going toward improving trout fishing.

Dean asked if DEEP is considering the same process for Marine and Warm Water Species fishing. Mike said they are working to go through a similar process for Warm Water Species but he could not speak for the Marine section.

Other Items

Alicea let everyone know that there will be a fly fishing event for Women on June 13, 2020. She will send out promotional materials to FAC members when they are ready.

Dean said that we have these quarterly meetings but do not have working group meetings to get thoughts together to present items

to DEEP and proposed that there be a follow up working group meeting in April after the march meeting.

Dean also suggested a "Derby Day." This would be a unified date to have various derbies throughout the state.
