- Limitation of boat size on Candlewood Lake, Effective March 6, 2013
 - Boats currently on the lake 26' and larger are grandfathered in as long as they can produce some type of document that shows the actual HULL of the boat has been kept on Candlewood.
 - o Marinas surrounding the lake are allowed to keep any boat in inventory on the lake until it is sold.
 - o Trial runs for boats potentially being sold will be allowed but boats must be removed when finished.
- New online program to obtain boating license or a lost boating license. Current issues with site but they are being worked on.
- New Boating laws being proposed at legislation but do not affect bass fisherman.

- On January 12th the audit committee, consisting of Vinny Mucci, Kevin Lavendar and Daniel Monroe met to inspect & verify the financial records of the CBN. Also present were Marc Levesque (Treasurer) and Sylvia Morris (President). Their attendance was necessary to answer any questions the committee may have had and their involvement in the audit process was minimal.
 - Meeting Called to order at 11:35am All transactions were reviewed as well as all supportive documents.
 - State Team Review:
 - Excessive Shipping costs shipping for next day air delivery when standard deliver could have been used as well as oversize shipping charges
 - Energy Drinks & Supplements while reasonable food & drink is covered, the cost of these drinks is excessive.
 - Above matters to be taken up to the executive committee for further review and clarification
 - One expense report was found to be in error. An underpayment of \$88.32 was made to a state team member for expenses. This was corrected and proper monies sent.
 - Also noted by the treasurer that club affiliation and angler names should be put on all checks, especially
 when a business or bank check is sent for payment dues or tournaments. Tournament director should
 also be sure to ensure the same information is on all checks he receives.
 - Youth:
 - Available records were reviewed. Records were limited to cancelled checks and supportive receipts. They were found to be accurate. Missing were expense reports and this has been discussed with the youth director and expense reports will be submitted on all future transactions.
