Boating Advisory: No Meeting Held

C.L.A. Report:

- Chris Bielert on the Invasive Committee No Formal Meeting
- Lake cleanup is scheduled for May 18th
- Lake Authority is dealing with reduction in funding from First Light. First Light is going to reduce their contribution by \$10,000 next year.
 - 4 out of 5 towns that surround the lake are also going to reduce their contributions by 20%. Sherman is the only town that is NOT going to reduce what they contribute.
 - \circ The reductions will severely impact what the Lake Authority does on a day to day basis.
- First Light is paying DR. George Knochlein to do a study on the effects of Blue Green Algae in Candlewood.
 - First Light believes the deep drawdowns contribute to the spread of these algae.
 - Candlewood Lake Authority disputes this and there is no conclusive evidence to prove this.
 - First Light is against doing these drawdowns to control milfoil.
- Zebra Mussel Task Force is continually monitoring Lake Lillinonah, Lake Zoar and Candlewood.
 - Number of both adult mussels and veligers continues to grow in both Zoar and Lillinonah.
 - Monitoring sites will be expanding this year to keep better track of expansion of adults.
- Dr. Kevin Kelly will be in charge of a CO₂ infusion study at Laurel Lake where we believe the mussels are coming from.
 - 1000 gallons of water flow out of Laurel Lake into the Housitonic River
 - First Light is going to use CO_2 at Dams on Lillinonah and Zoar.
- Lake Authority is exploring the option of using Triploid Grass Carp
 - State of CT will consider issuing a permit if the Lake Authority chooses to move forward.
