# **CBN Conservation objectives for the 2018**

- Conservation Projects for Candlewood Lake (Boat Launch & Habitat)
- 2. Create a C.A.R.E. Bass Class
- 3. Create an on the Water Bass Course (like Golf Course)

# Information from this past Month -

- 1. CT Conservation Advisory Council (CCAC) Meeting
  - a. Keith Cagle, President of the CCAC was absent and I ran the meeting
  - b. I presented our letter of gratitude to the representative of the Northwest Sportsman Council and expressed our thanks for their support.
  - c. Discussed the various meetings about the Candlewood launches

- d. Discussion on Sportsmen Access to Fishing and Hunting
- 2. Fisheries Advisory Council
  - a. Budget and Legislative Report Bill Hyatt
    - i. 12 positions were approved for BNR!
    - ii. One position lost with the resignation of a Fisheries biologist in Habitat, Conservation and Enhancement program. This is a federally funded position so there is a chance that it can be refilled.
    - iii. State funding income is fairly stable. No budgetary need for additional cuts going forward.
    - iv. Federal funding
      - 1. Sport Fish Restoration Act funds are up 12%
      - 2. Wildlife Restoration Act Funds begun to settle in to a normal pattern
    - v. Association of Fish and Wildlife Meeting State level data from national survey many not meet data needs as they have in the past due to reduced resources for survey and analysis. Results do not correlate with local data. CT will most likely decline to use the report.
    - vi. Legislation
      - 1. Concepts being developed for the next session -Reg change to remove requirement that notices must be put in the Newspaper.
    - vii. Recovering America's Wildlife Act currently the Senate Bill requires that the funding be appropriated each year. This will be problematic.
    - viii. Bill announced that he will be retiring at the end of the month. Has submitted paperwork to make Rick Jacobson acting Bureau Chief. Submitted simultaneous paperwork to refill the Bureau Chief position. It will be a competitive process. There will be a retirement party for Bill on October 12<sup>th</sup> 5:00 pm at Sessions Woods in Burlington.
  - b. Trout and Salmon Stamp Art Contest Mike Beauchene
    - Youth Based contact point for next generation of anglers

# ii. Focus on TIC and SIS

- 1. Leverage existing relationship
- 2. Interdisciplinary connection (Science and Arts)
- 3. Potential to connect with DEEP CARE
- iii. Develop logistics (model CT Waterfowl Assc Duck Stamp Contest)
  - 1. Organizational lead, Develop Rules, Assemble Judges, etc.
  - 2. Printed stamp made available for licenses?
  - 3. Art for sale?
  - 4. Calendar (Similar to LIS)?
  - 5. Other ways to use the contest to promote fishing

#### iv. Member discussion

- 1. Jason Vokoun gave a synopsis of the Duck Stamp program and would not advise investing in limited edition stamps that would be sold due to the current market for fish and wildlife art.
- Mark Swenson had the suggestion that the request goes to the Paier School of Art and the Universities which may bring the offer down to the High Schools.
- 3. Jack suggested that a committee be formed Mark Swenson, Sam D'Ambruoso, Jason Vokoun and Tom Chrosniak agreed to be on the committee.

#### c. Fishing Access Easements - Greg Sharp

- i. The Waltonian Club once had easements (an 1870 deed) on the Farm River in North Branford with exclusive rights to fish. When the Club went out of business, it deeded the easement to the State in 1942. The problem now is that there is no longer signage on any of them. Greg fears that landowners will not allow anglers to use the property. Deed searches only go back 40 years.
- ii. Greg reported that Graham Stevens said there have been issues on the Housatonic with a similar easement situation because the language of the easement was not specific enough.

- iii. Another potential issue is that the Attorney General's office prefers to have an A2 survey.
- iv. Peter Aarrested said that there are college students who are looking for internships and perhaps this would be a good issue to address with interns.
- v. Tony Petrillo said he has a list of land purchased with federal money and can provide this to Greg.
- vi. Brings up the question of signage.
- d. New signage for areas stocked/managed for trout
  - i. Mike Beauchene gave a presentation of proposed signage to bring attention to stocked water.
  - ii. Mark Swenson said that there will be an issue with anglers not knowing where they can park and may cause issues with local residents where the signs are posted. Also, that the signs should be visible from the road.
  - iii. Mike Piquette said that they should be color coded.
- e. Inland Fisheries Report Peter Aarrestad
  - i. Quinnebaug is making improvements good information in the report
  - ii. Sam asked if there has been a determination as to how widespread the zebra mussels infestation. Pete said the impoundments will become most prominent.
  - iii. Mark Swenson asked if temperature monitoring data will be available. Peter said it can't be made available on an instantaneous basis but will talk about it more internally.
  - iv. Dean Rustic asked about weed treatments on Lillinoah. Contractors have received permits hired by homeowners but the landowners' land ends at the water line. Other landowners have expressed concern about this as well. Pete said these are valid points about the process and he is not sure this can be addressed at the agency. He thinks this may be an issue for our legislators to resolve. Dean also asked "how far a dock could extend into a lake?" Greg said that the town inland and wetland commissions have jurisdiction over structures.

- v. Justin Davis is now the Assistant Director
- f. Marine Fisheries Report Justin Davis and Dave Molnar
  - i. Atlantic Herring Stock is not doing well. Fishery has been reduced. .
  - ii. Scup Stock is in good shape so quotas are the same.
  - iii. Black Sea Bass Stock is at 250% of target biomass. But because the last assessment was done in 2014, the data has not caught up with current conditions. Another assessment in 2019.
  - iv. Summer Flounder All indications that populations are not in great shape and we are very close to over-fishing the stock.
  - v. Atlantic menhaden Virginia is not in compliance with the fisheries management plan. Unfortunately, there will be no consequences and will be given another chance to come into compliance.
  - vi. American Eel Populations are depleted. Cap remains at current level but prevented an increase.
  - vii. Angler Survey (Wave 3) Fewer anglers but catch rates were higher
  - viii. Headboat Sampling a good way to get discard length data.
    - ix. Marine license sales are slightly down this year

#### 3. **DEEP Items**

- a. Keith Cagle, President of the CCAC and I met with Bill Hyatt, Michael Lambert and Tony Petrillo of the CT DEEP on Friday August 31<sup>st</sup> at Squantz Cove Boat Launch. It was clear to all in attendance the need for safety improvements at this facility. The following Items were discussed:
  - i. Widen the current boat ramp
  - ii. Provide a courtesy dock system in addition to the launch pier
  - iii. Clear and create a Handicap parking area near the launch
  - iv. Widening of the park entrance
  - v. Marking designated parking areas
