- 3. DEEP Items
  - a. Edward Machowski is looking for support and some input from the CBN:
    - i. Ed wrote "I want to get a better handle on the status of fish and fishing on our current list of Bass Management Lakes. Attached

is an excel file that has the lakes listed by type of regulation and when the regulation took effect. I will be adding a lot more data to this file, but what I would like is for you guys to look over the list of lakes and give me your impression as to the status of the fishery. Is it good, declining, improving etc.. I will be adding in our sampling data and evaluating pre and post regulation change, but sometimes our data doesn't tell the whole story. I will also be creating a list of lakes currently not part of our Bass Management Lakes (e.g., East Twin, Lilli. . .?) to determine which of these additional waters might benefit from a regulation change or some type of management."

- b. Burr Pond Shore fishing site review. Tom O'Connor of MVBC assisted me in doing a site review from the water for possible areas that could be cleared along the trails to allow for more shoreline fishing. With this information I will be meeting with Edward Machowski and Tammy Talbot (West Parks Supervisor) to discuss what can be done.
- c. Discussion with DEEP on the effectiveness of the habitats we placed at lakes Housatonic, Zoar and Lilly. Will seek to develop a plan for measuring by early spring.
