• Hello to the Environmental Committee -

My name is Dean Rustic and I am the Conservation Director for the CT BASS Nation. I am also the Vice Chairman of the Fishing Advisor Council and also the Vice Chairman of the CT Conservation Advisory Council. I live in Burlington, CT.

I come before your committee today to represent the CT Sportsmen and Sportswomen and provide their view point from the organizations I represent.

The CT Sportsmen & Sportswomen support the concept of a funding source to aid in protecting our inland waters. We are extremely cautious with the current writing of the bill. We have seen where legislation written poorly will have dire consequences. Our most major concern is that the CT Taxpayers could have their access to public water bodies taken or restricted due to this bill.

The good intentions of this bill place the burden only on the existing CT Residents who are already be taxed. The CT Sportsmen & Sportswomen are already taxed on our purchases of Boating, hunting & fishing gear. Those funds that are paid to the Wallop-Breaux Tax come back to CT based on the number of fishing that are sold. Last year CT received over \$3.5 Million from this fund and is slated for \$3.6 Million this year. These funds from our tax dollars go to:

- Boating Safety Programs promote the use of personal floatation devices (life jackets), courses on basic navigation, weather signs and appropriate safety gear; and enforcement of responsible boater conduct and speed zones
- Boating Infrastructure Grants boost local tourism and economic development by creating new facilities for transient boaters needing a slip or dock.
- Clean Vessel Act allows states to purchase and maintain pumpout facilities (for boat discharge) that are more accessible and reliable.
- Coastal Wetlands Restoration maintains our nation's wetlands.
- Sport Fish Restoration maintains fisheries and protects our natural resources.
- Recreational Boating and Fishing Foundation supports conservation of aquatic natural resources by increasing participation in and appreciation of water activities.
- Boating Access Programs.

My point here is to show that CT Sportsmen & Sportswomen are stalwart's to the environment as we have been paying this tax to ensure our environment is safe with clean water and healthy fish. The CT BASS Nation, and many others, have already adapted Clean, Drain & Dry program to help stop the spread of the invasive aquatic species as well as other proven conservation efforts.

There needs to be a larger effort to educate all folks who use the CT Lakes, Ponds & Rivers about what they can do to stop the spread of AIS. A sailboat, rowboat, canoes and kayaks all have the ability to transport AIS. The owners of these vessels need to be educated. We feel they should also support the AIS Stamp Fund.

We wish to have the following concepts added to the current wording of the bill:

- **1. Funds from this Stamp will only be used to help bodies of water that have unrestricted public access for Motor Boats.**
- 2. Towns, Municipalities and Lake Authorities who receive funds from this stamp will not be able to use these funds to limit motor boat access to public waters.
- 3. Towns, Municipalities and Lake Authorities who receive funds from this stamp will allow motor boats on the lake without any horsepower restrictions.
- 4. With the narrow scope of the stamp focusing on motor boats, verses all water craft using CT Waterways (Boat, canoes, Sailboats, Kayaks etc). Therefore bodies of water that do not have public access for motor boats are prohibited from using funds from this stamp until the stamp is expanded to include nonmotor boats in the funding source.
- 5. Using the DMV verses the CT DEEP Online Licensing System to capture the funds – The CT DEEP has an online License system that allows for 7x24 access to acquire Licenses and Stamps. Using the DEEP system will be much easier and user friendly.
- 6. Many States are now including in these types of tax bills or stamps, wording that states that there is a fundamental right for CT Residents to have public access on these water bodies for Hunting and Fishing.

By doing this, we will not present the individual event plaques at the banquet; we will only hand out the overall winners that night.

We will not do this for the juniors for this year, as we will probably only have 2 or 3 tournaments for the 6 Jr. anglers.
