Conservation Advisory Council (CCAC) Meeting No Meeting 2. Fisheries Advisory Council OFFICER'S REPORTS • Secretary's Report – Motion by Eric Schultz to approve minutes from 11 Jun 20. Motion seconded by Bill Hyatt. All were in favor. • Chair's report -Dean Rustic o Dean proposed that the meetings through March continue to be held virtually. Hopefully, a June in-person meeting will be possible. Potentially an outdoor meeting. o Membership growth – Dean has reached out to a few new groups that would be valuable new members. Mary Moulton volunteered to serve as the Membership Chair. o Considering a BAG – Bass Advisory Group – Marinas, Bass anglers, etc. o There was some discussion of how the FAC should be structured and some concern was expressed about "tribalism." COMMITTEE & INITIATIVES REPORTS • Boating Update Mike Payton & Peter Francis o Boating division has had to close some facilities in response to increase in COVID cases. After consultation with DPH, DEEP feels that the launches are unlikely to spread the virus. However, there have been large groups gathering after being out on the water and this is the main concern and reason for closure, o 124 boat launch closures due to capacity. Triple from last year, o Improvements to Squantz Cove Boat Launch **♣ Mike Payton described the layout so that the group can** understand what is being proposed. * The new layout will make flow better and include a canoe and kayak launch as well as other improvements and amenities. * Once the design has been drafted, there will be a public information meeting and request for comments. There may be an opportunity to have an outdoor meeting where posters of the design can be presented. The design will also be posted on DEEP's website for the public to view. ♣ Mr. Payton expects a significant amount of interest in the project. * Changes will be made based on public comment. Then the project will go through a permitting process. It is expected that the permit will go to a public hearing. Would not expect construction any time prior to the summer of next year. • Budget and Legislative Report -Rick Jacobson & Tony Petrillo o New Deputy Commissioner - Mason Trumble. A priority of Mason's is to advance the 3R efforts. He will join us for the December meeting. o Provided a brief on the Governor's Council on Climate Change activities and the Rivers Subworking group. o Communications Survey - DEEP would like to know

how hunters, anglers, etc would like to be reached and how to get to this information in the quickest and easiest manner. o Finance – no new news relative to the budget. * Bonding • 2020 renovation of Quinebaug Hatchery – \$5.8 MM project. \$2.2 MM budget gap. Think that EO 1 increased the funding available to fill that gap. • Rainbow Fishway – replacement with rainbow fish lift. The current fish lift was designed for Salmon and was state-of-the art at the time but is ineffective for American Shad. Similar price point to the Quinnebaug hatchery (\$6 MM.) Elevate the bond proposal through the Deputy Commissioner and Commissioner. Why is the public paying for this fish lift? Legal team is doing an analysis on funding responsibility. 🛧 Bill asked if there has been any progress on the Recovering America's Wildlife Act. House of Representatives has passed a second CARES Act which does provide \$3 trillion in federal aid. **Encompassed within that is RAWA. The Senate has balked at the** House's bill. • Inland Fisheries Report – Peter Aarrestad o A presentation on AIS was given (attached) o Inland fisheries presentation was given (attached) o General comments and questions ♣ Trout in the Classroom – Peter will reach out to staff to find out what is going on with TIC this season. * Concern about possible drowning on the Housatonic. There are no signs that say no swimming. • Marine Fisheries Report – Justin Davis o Some field sampling programs have resumed since June. o Did not resume LIS trawl survey because it involves a large crew on a small boat o Many for-hire boats are doing well during the pandemic but the headboats are not o ASMF adopted ecological reference points for menhaden. o Striped bass * All states on the coast must implement regulations requiring circle hooks. Emergency regulation will be put in place as a gap measure. Final regs are being developed and a public hearing for implementing rule will be in 2021. * Amendment to the striped bass management plan - large potential changes to management. Will be public hearings in the next year. o Scup and black sea bass - substantial reductions in recreational bag limits. Have been successful in not having the implement this each year. o Missed critical months for angler surveys. Not sampling head boats. Seeing a lot of fishing and fishing pressure. o Invasive mitten crab has been found in Housatonic estuary. o License data – 10% increase in inland and marine anglers. • New Business o Given the

presentation that Rick made that there are two major funding issues that will be bond commission issues. The FAC should resurrect the legislative committee. Nominated Bill as the chairman of the legislative committee. Motion was made to resurrect the committee by Greg Sharp and seconded by Eric Schultz. Bill said he is willing to chair and pull together a committee. All were in favor.
