CBN Conservation objectives for the 2023

- 1. Conservation Projects for Candlewood Lake (Boat Launch & Habitat)
- 2. Create a BASS Divisional Conservation Coalition to get a Grant for Habitat

Information from this past Month -

- **1. CT Conservation Advisory Council (CCAC) Meeting**
 - a. Andy Fisk has resigned as BNR Bureau Chief to take a position at American Rivers. Jenny Dickson is now serving as the acting Bureau Chief.
 - b. Triploid Grass Carp removal efforts at Candlewood Lake have been conducted on 5/18, 5/24, 5/25, 8/23, 8/31, 9/9, and 9/11. Attempting to remove enough carp to enable some recovery of submerged aquatic vegetation. Have removed a total of 180 carp so far. Two additional days were scheduled in September. Fisheries estimates that there are 1,500+ grass carp remaining in the lake. (See the minutes from the June CCAC meeting for additional detail).
 - c. Fall trout stocking began in late September. Flows are good but stream temperatures are still too high. 34 lakes & ponds and 23 streams will be stocked with 60% rainbow trout, 21% brown trout, 10% tiger trout, and 3% brook trout. Also anticipate stocking 1,500 Atlantic salmon broodstock into two lakes (Crystal Lake and Mt. Tom Pond) and two rivers (Shetucket River and Naugatuck River).
 - d. Hydrilla (a highly invasive aquatic plant) is showing up in more waters. New locations include Merckaur Pond (Silvermine drainage), Amos Lake, East Twin Lake, and Lake Pocotopaug. Also reported but not yet confirmed in Lake Lillinonah. All these new findings are genetically similar to the unique strain that was found in the CT River in 2016. The concern is that these weeds are being transported to new locations by boaters. [Note: On 10/1 the Hartford Courant published a large front page article on the damage being caused by hydrilla in the CT River]
 - e. NOAA announced that they have identified some problems with the Marine Recreational Information Program. These

problems likely resulted in 30%-40% overestimates of the number of marine sportfish (such as striped bass etc.) being harvested. NOAA will be working to better understand these errors and will work with the states to implement corrective measures. Harvest data is essential to the management process and influences the setting of fishing regulations that impact anglers, guide services, and commercial fishermen.

- f. Forestry Director Chris Martin believes that the statewide reports of leaves turning brown and dropping from maple trees are likely being exaggerated.
- g. The Humane Society tried to advance legislation in Rhode Island banning fur sales. It didn't go anywhere.
- h. Discussion of SCORP Surveys being done on X/Twitter: Keith and Dean have been attending SCORP meetings. Concern that surveys on forums such as Twitter are biased and aren't representative. Also concern that this is the same survey that was circulated previously to the CCAC/Sportsmen with a June 1 deadline. How is the Agency combining and using this data? Andrew Bade will look into this and will get back to the group on if the deadline has been extended.

 - a. Next meeting December 14th Agenda Items -

 - c. Discussion on CT River Hydrilla
- **3. Friends of CT Sportsman (FOCS)**
 - a. Working with the CCAC to advocate for updated Fishing, Hunting & Trapping regulations.
 - b. Presenting additional learning opportunities to Sportsman about the changes for Fishing & Hunting.
- 4. DEEP Items

- a. Discussed working together to apply for a Friends of
 Reservoirs grant for 2024 to put structures into Candlewood
 Lake to help offset the extreme loss of aquatic vegetation.
 - a. One potential project idea would be to get new vegetation established in Candlewood.
 - b. The other FY 2023 grants will probably be due in August 2023

Proposal #1 Executive Board Tournament Trail Proposal for 2024

(To be brought back to your clubs, discussed at the November meeting, and voted on at the Dec meeting).

- Raise the Entry fees to \$120.00 for a Boater and \$60.00 for a Non-Boater for the 2024 Season, leaving the 25% coming out of each entry fee to go towards offsetting the cost borne by the 2025 National Qualifiers from the 2024 Trail.
- 2. Eliminate the \$25.00 Late fee and only use the Mailing Deadline Date (Postmarked by date). If it is not postmarked by that date (15 Days prior to each Tournament Date) it will be returned!

Executive Board 2023 By Law Proposal for 2024

This will be brought back to your clubs, discussed at the CBN November meeting, and roll call vote at the Dec meeting.

We are looking to eliminate the November, December and January meetings going forward, if it gets voted in, the below is the necessary By-Law Change:

AS IT READS NOW IN THE 2023 CBN BY LAWS:

Attendance

It shall be required that all of the Chapters in the Connecticut B.A.S.S. Nation shall have a representative in attendance at least ten (10) out of twelve (12) consecutive meetings. (Refer to Article VIII, F.). When a Chapter representative does not attend a CBN Meeting, that Chapter shall be recorded as absent. That Chapter shall then be responsible to petition the Board of Directors, if they wish to be excused for the meeting which they missed. This must be done at the next Board Meeting, after the one which has been missed. Excused absences shall be limited to two (2) in any consecutive twelve (12) month period. If a chapter does not comply with this rule, said chapter shall not be eligible to participate in any CBN activity; (including the Connecticut B.A.S.S. Nation State Championship Tournament). The Executive Board shall determine eligibility of clubs affiliated less than twelve months.

CHANGE TO:

C. Attendance

It shall be required that all of the Chapters in the Connecticut B.A.S.S. Nation shall have a representative in attendance at least 8(8) out of nine (9) consecutive meetings. (Refer to Article VIII, F.). When a Chapter representative does not attend a CBN Meeting, that Chapter shall be recorded as absent. That Chapter shall then be responsible to petition the Board of Directors, if they wish to be excused for the meeting which they missed. This must be done at the next Board Meeting, after the one which has been missed. Excused absences shall be limited to one(1) in any consecutive twelve (12) month period. If a chapter does not comply with this rule, said chapter shall not be eligible to participate in any CBN activity; Including the CBN Tournament Trail qualifying for the Nationals.

The Executive Board shall determine eligibility of clubs affiliated less than Twelve months.
